Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the **2021** baseline.

Carbon Reduction Measures taken over the last twelve months:-

- Meetings conducted via Teams / Zoom wherever possible to reduce unnecessary energy usage when commuting.
- Working from home days encouraged.
- Purchase of energy efficient IT equipment. This involved replacing existing PC's with laptops as these are 80% more energy efficient.

In the future we hope to implement further measures such as:-

- Achievement of ISO 14001 accreditation.
- Encourage the use of Teams / Zoom to conduct meetings as opposed to driving to every meeting, reducing unnecessary energy usage.
- Incorporate 'working from home' days to reduce travel, office heating and air conditioning.
- Introduction of a complete paperless system to avoid unnecessary use of paper and energy. Any essential printing must be done double-sided.
- Encourage members of staff to 'go green', i.e., bring lunch to work to avoid unnecessary travel or plastic usage, purchase electric vehicles, use public transport or car share.
- Replace existing water cooler with tap filter to reduce the use of plastic.
